DISCLOSURE TEXT FOR PROCESSING OF PERSONAL DATA

Our Company, Remik Kimya Sanayi ve Ticaret A.Ş. ("Remik Kimya") which is a data controller pursuant to Article 10-"Disclosure Obligation of Data Controller" of the Personal Data Protection Law No. 6698 (the "PDPL"), has the obligation to inform data subjects about the identity, the purposes of personal data processing, the persons to whom the personal data is transferred and the purposes of transfer, the legal reasons and methods of collecting personal data, the rights listed in Article of 11 the PDPL that the personal data subject will claim from the data controller. In accordance with this Article, this Enlightenment Text has been prepared for the purpose of informing you data subjects in accordance with the provisions of Article 10 of the PDPL.

a. Identity of Data Controller

Data controller has been defined in Article 3/1(i) of the PDPL as "any real or legal person(s) who determines the purposes and means of personal data processing and is responsible for establishing and managing the data recording system". Article 10/1(a)-" Enlightenment Obligation of Data Controller" of the PDPL imposes the obligation to inform the data subject about the identity of the data controller.

Remik Kimya may be the 'data controller' within the scope of the PDPL due to your personal data that you share with us on this website or other channels. In this context, the "data controller" is Remik Kimya Sanayi ve Ticaret A.Ş., established as a joint stock company in accordance with laws of the Republic of Turkey, registered with the Istanbul Trade Registry Office under the

Registration Number: 191913/0, with CRS Number: 0734006530327280 and with registered address at Esenler Mahallesi, Kahramanlar Caddesi, No:71, 34899, Pendik / Istanbul.

b. Purposes of Personal Data Processing

Your Personal Data is processed in accordance with the personal data processing principles specified in Article 4 of the PDPL, based on one or more than one of the personal data processing requirements specified in Article 5 of the PDPL. Remik Kimya complies with all the obligations provided for in the relevant legislation, particularly in the PDPL, in all personal data processing activities carried out by Remik Kimya.

c. To whom and for what purpose personal data processed may be transferred

Your personal data collected may be transferred to our business partners, suppliers, shareholders, legally authorized public institutions and organizations and private persons for the purposes of carrying out by our business units the work necessary for you to benefit from the products and services offered by our Company; selling and marketing of our Company's products through this website; recommending the products and services offered by our Company to you by customizing the same for your likes, usage habits and needs; ensuring the legal and commercial security of our Company and those who have a business relationship with our Company and determining and implementing our Company's commercial and business strategies, within the framework of the personal data processing requirements and purposes specified in Articles 8 and 9 of the PDPL or for the limited purposes specified in in the Policy on Processing and Protection of Personal Data of Remik Kimya Sanayi ve Ticaret A.Ş. in our website accessible at www.remikkimya.com.tr or www.remikkimya.com.tr or www.remikkimya.com.tr or www.remikkimya.com.tr

d. Method of, and legal ground for, collection of your personal data

e. Rights of Personal Data Subject

You, as a personal data subject, can submit your requests for your rights to our Company using the methods set out in the Personal Data Processing and Protection Policy of Remik Kimya Sanayi ve Ticaret A.Ş., shared with the public in our website and available at www.remikkimya.com.tr

or <u>www.remikkimya.com</u>. Based on the nature of the request, Remik Kimya shall finalize the request free of charge as soon as possible and within 30 (thirty) days at the latest.

In case the information you request from our Company regarding your Personal Data requires any additional cost, such information will be provided on the condition that the fee in the tariff determined by the Personal Data Protection Board is paid. The rights of natural persons whose personal data is processed pursuant to Article 11 of the PDPL are as follows:

- > to find out whether their personal data has processed;
- > if their personal data has been processed, to request for information related thereto;
- > to find out the purpose of processing of their personal data and whether or not their personal data is used properly;
- > to know about third-parties to whom their personal data is transferred home or abroad;
- in case personal data is processed incompletely or incorrectly, to request for correction of their personal data and for notification of such correction to third-parties to whom their personal data is transferred;
- > in case of disappearance of the grounds that require processing of their personal data although processed in accordance with the provisions of the PDPL and other relevant law, to request for deletion or destruction of their personal data and for notification of such deletion or destruction to third-parties to whom their personal data is transferred;
- > to object to the emergence of any consequence against the person himself/herself through analysis of the data processed exclusively by means of automatic systems;
- > in case of any loss and/or damage due to the unlawful processing of personal data, to claim indemnification for losses and/or damages suffered;

We would like to use your Personal Data in order to inform you about our products and services, without prejudice to those we are required to save due to our legal obligations and contractual relationships. It is at your discretion to allow us to use your Personal Data for this purpose, and if you do not give consent or want to revoke any previous consents, your Personal Data will be closed to access and their use for these purposes will be discontinued.
